

# **Physician Assistant Program Frequently Asked Questions**

### Admissions Timeline of application submission for the January 2026 Class: November 1, 2024 – April 1, 2025

# **Admissions Requirements**

- Undergraduate degree (Bachelor's) must be received from a regionally-accredited college/university prior to matriculation into the program.
- Required cumulative overall Grade Point Average (GPA) of 3.0 on a 4.0 scale.
- Required Science Grade Point Average (GPA) of 2.9 on a 4.0 scale.
- Completion of all prerequisites prior to matriculation. Applicants with *more than* four (4) outstanding prerequisites in the spring, three (3) outstanding prerequisites in the summer and two (2) outstanding prerequisites in the fall cannot be considered for admission. The CASPA application must include a plan for completing the remaining prerequisites prior to enrollment. The prerequisites for Mercer's PA Program are:
  - o two course General Chemistry series with labs
  - o one course of Organic Chemistry (lab optional)
  - o one course of Biochemistry (lab optional)
  - o two course General Biology series with labs
  - o two course series of Human Anatomy and Physiology with lab (or A&P 1 and A&P2)
  - o one course of Microbiology with lab
  - o two course English Composition or intensive Writing course series
  - o ne course of Statistics or Biostatistics
  - o ne course of General or Introductory Psychology

#### Notes about prerequisites:

- Anatomy, Physiology, and Microbiology must have been taken within the last 10 years.
- o Survey courses are not acceptable towards the prerequisite coursework.
- o Online coursework will not satisfy laboratory course requirements.
- o Only grades of C or better are acceptable for prerequisite coursework.

- Required Patient Care Experience Hours: Applicants are required to complete a *minimum* of 1,000 hours of direct, hands-on patient care experience.
- Qualified applicants with complete files and who meet or exceed the admissions criteria listed above may be invited to campus for a personal interview.
- Applicants must also meet the PA Program's Technical Standards in order to be considered for admission into the program

#### What materials are required to apply to the Physician Assistant Program?

PLEASE NOTE: It is highly recommended to submit your application early in the cycle and ensure that all required documents are in progress or submitted no later than 2-3 weeks prior to the final deadline of April 1st. The CASPA verification process and the distribution of Casper scores necessitate 2-3 weeks for completion. Only applications that have been deemed complete and verified by CASPA will be reviewed after April 1st.

- Primary application must be submitted online through **CASPA**: www.caspaonline.org. All official transcripts must be submitted to CASPA.
- Supplemental application must be submitted online via the Mercer website: http://chp.mercer.edu/admissions/admissions-requirements/physician-assistant/

- GRE scores are optional, not required. However, if you wish to have your scores considered with your application, please request your scores at least two weeks prior to the deadline so they will be received in time. Official GRE scores must be sent from ETS to CASPA using the institution code 0441 (Mercer U Phys Asst CASPA) in order to be considered.
- Completion of the CASPer assessment. Applicants will register for the assessment at
  https://acuityinsights.app/ and will sign up for CSP 10101, Professional Health Sciences. Direct
  your results to Mercer University and the scores will be sent to PA Admissions in approximately 2
  weeks from the test date.
- Clinical Experience demonstrating direct, hands on patient care (1,000 hours required). This experience must be included in the **CASPA** application under the "Patient Contact Experience" section. Additional indirect health care experience should be included in the "Other Health Care Experience" section of the CASPA application. Applicants should be careful not to duplicate information in multiple sections of the CASPA application.
- Three letters of reference must be submitted to **CASPA**. At least one letter must come from a practicing physician assistant or physician (MD/DO) and one must come from a college professor or instructor. The third letter can come from a non-relative professional.
- International applicants or domestic applicants with credentials from institutions outside the United States are required to have those credentials evaluated by a professional evaluation service. This evaluation must include an analysis of courses, grades and grade point average, and U.S. degree equivalency. Mercer University accepts evaluations from the following three services:

An official evaluation report must be sent to the admissions address to be included in the application. Applicants whose native language is not English must also demonstrate satisfactory proficiency in English language as measured by the Test of English as a Foreign Language (TOEFL). Until this procedure has been accomplished, an application for admission cannot be considered.

#### Why do you require candidates complete at least 1000 hours of patient care?

Applicants are required to complete a minimum of 1,000 hours of direct (hands on) patient care experience. Successful applicants often exceed the minimum number of hours. Current students accepted in previous admission cycles had direct patient care experience ranging from 1,000 to over 13,000 hours. Applicants without previous health care experience are often able to acquire acceptable direct patient care experience working as a medical or nursing assistant or aide in settings such as hospitals, clinics, or physicians' private practices where a wide range of patients is seen and there is an opportunity for exposure to numerous types of health care providers. Volunteer patient care experience in a long term care or hospice setting is also acceptable.

Applicants are also encouraged to shadow a PA to learn more about the daily routine/role of the PA; however, this experience *does not* count as "direct" patient care experience.

Below are desirable, partially acceptable, and not acceptable examples of direct patient care experience:

**Partially acceptable**: Hours for a partially accepted position are credited at 50% with a limit of 500 hours for the position.

- audiologist
- child life associate
- dental assistant/hygienist
- exercise physiologist

#### NOT acceptable:

- aerobics instructor
- CPR or ACLS instructor
- laboratory-based researcher
- life guard
- massage therapist
- medical registrar
- non-clinical research positions
- patient transporter
- peer educator
- personal (fitness) trainer
- pharmaceutical representative

- shadowing
- ski patroller
- unit or medical secretary
- volunteering at marathons, blood donor clinics, fundraising for medical causes, etc.
- ward/insurance clerk
- reader or other non-medical work in waiting room or other medical setting

Although valuable to the practice of medicine, clinical experiences which lack direct patient care responsibilities are not competitive and do not prepare students for successful completion of our Physician Assistant Program.

#### **PA/MPH Combined Degree Option**

Mercer University's College of Health Professions is pleased to offer the Master of Medical Science/Master of Public Health (MMSc/MPH) combined degree program. Given the need for primary healthcare providers in rural and other medically underserved communities, the MMSc/MPH combined degree program specifically focuses on providing rural and other underserved communities with well-trained public health minded primary care providers who have the ability to address societal health concerns and evaluate community-based programming. The primary target audience includes students with strong academic records who demonstrate an interest in community-based health promotion and primary care practice. Applicants must apply to each program separately, according to the guidelines in the Admissions Process and Requirements section for the PA and MPH programs. After successful admission to the PA program, the student with a strong academic record who demonstrates interest in community-based health promotion and primary care practice will apply to the MPH program. The admissions requirements for the combined degree are the same as for each individual degree.

<sup>\*\*</sup>Other fees include fees for lab, medical equipment, and other costs associated with background screenings/drug tests and immunizations as required by the PA Program and its clinical affiliates.

<sup>\*\*\*</sup>This estimate does not include other expenses (i.e. laptop and PDA, housing, transportation, professional organization dues). We recommend you budget an additional \$5,000 to cover expenses associated with the 15 months of clinical internship.
