

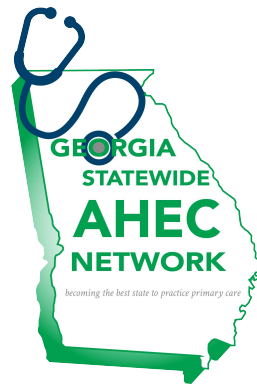
## Registration

**Preceptor:** A one-time registration\* is required; no need to renew annually but can edit key information changes.

Preceptors will work with our eligible academic programs to discuss student hours and rotation schedules. Academic programs submit information certifying that student rotations with a preceptor have been completed. **Preceptors do not submit rotation data.**

# What is PTIP?

*The expansion to dental preceptors and the removal of the incentive structure is effective January 1, 2026.*

Georgia's Preceptor Tax Incentive Program (HB144) allows licensed, community-based preceptors (MD/DO, DDS/DMD, APRN, PA) who provide uncompensated clinical training to students from Georgia's medical, dental, APRN, and PA programs to earn tax credits. Physicians and dentists can earn up to \$10,000 annually, while APRNs and PAs can earn up to \$7,500 for the same period. Credits are awarded for student rotations (160 hours of training per credit), with up to 10 credits per year. Initially introduced as a deduction in 2014 and later expanded, this program supports and recognizes volunteer preceptors' essential role in healthcare education.

Licensed Physician/ Dental Preceptors:  
Rotations 1-10 earn \$1,000 per rotation  
Maximum Credit Available= \$10,000

Licensed APRN or PA Preceptors:  
Rotations 1-10 earn \$750 per rotation  
Maximum Credit Available= \$7,500

*If a student only needs 80 hours for their rotation, the preceptor will need to provide two rotations that would total 160 hours to qualify for one credit.*

*If your partner precepts with you, you can claim the rotation fully, alternate claiming rotations with your partner, or each of you claim a percentage of the hours earned.*



## Eligibility

- Licensed MD, DO, DDS, DMD, APRN or PA in GA
- Cannot receive direct compensation from any source, for teaching medical, osteopathic, dental, APRN, or PA students.
- Credits only available for rotations supporting Georgia medical, osteopathic, dental, APRN or PA programs.
- A maximum of 10 rotations may be claimed each calendar year.

## Certification

The Statewide Area Health Education Centers (AHEC) Program Office at Augusta University administers the program and certifies rotations.

**Only** the AHEC Program Office can certify eligible rotations and issue tax letters.

Individual academic programs will report completed qualifying hours to the AHEC Program Office.

Credit will be certified by the Georgia Statewide AHEC Network Program Office and a letter issued by January 30 of each calendar year.
